REFUND OF MEMBERSHIP FEES POLICY

Orchard Beach Golf and Country Club membership includes refund protection for paid up members. This protection is rare in the golf business and reflects the value we place on having a long-term relationship with our members. If due to injury or sickness, a member is unable to golf for the balance of the golf season, the club will refund a portion of club dues, cart and trail fees but not any other fees. The amount of refund is based on calendar dates. A schedule of dates will be published annually as will the associated refund rate for such refunds. During the golf season the General Manager will inform the Board of Directors of refunds paid.
